ITEMS DISCUSSED AT AGM

<u>ltem 1.</u>

Further explanation was given by the Secretary, Helen Wickens, of the planned "Celebration of 100 Years of Narpo" at Thursford on Saturday 27th July 2019. Planning has been moving forward and it has been decided that a buffet style meal should be preferred to a sit down banquet. This will allow more members to attend the event.

Entertainers are in the process of being booked. And, discussion was held as to the possibility of providing transport to and from the event on the day,

More detail will be given in the next Newsletter.

<u>ltem 2.</u>

The criteria to become a member of the Norfolk Branch of NARPO, was discussed, due to the changes in Narpo Rules.

In September 2017 the National NARPO Conference approved New Fund Rules, and at the Norfolk Committee meetings in October 2017 and January 2018, consideration was given to the implications of the new Rules on the Branch.

The new Rules:

Rule 6.1 States: Membership of the Association is at the discretion of the Branch.

Rule 7.1 States: All applications for membership shall be made to the relevant Branch Secretary who shall decide whether to accept or refuse the application.

There are now two clear main categories of membership:

<u>FULL MEMBER</u>: Defined by Rule 6.2 – these are essentially retired police officers **entitled** to a police pension. The wording has changed as previously a full member had to be in receipt of a pension. The new wording allows those who have left the Service with a deferred pension etc to now join.

A Full Member can hold office and attend the national conference as a delegate and be elected to the NEC.

<u>MEMBER</u> : Defined by Rule 6.3 - a Branch may grant 'membership' to any person who is not eligible to join the Branch as a Full Member. They can not hold office or become a delegate to conference etc.

Therefore, onus to accept or refuse an application to be a 'Full Member' or a 'Member' falls on the Branch Secretary.

The Secretary, Helen Wickens, quite rightly wanted a 'clear steer' from, initially, the Branch Committee, and then secondly ,from members at the AGM, as to the criteria she was to adopt and apply when making a decision on membership, ensuring that we do not discriminate but act in a fair and open manner.

So, initially at the last Committee Meeting, held on 16th January 2018, a full discussion took place and the overwhelming comment was ...and the clue is in the name ...National Association of <u>Retired Police Officers</u>.

The Assistant Secretary, Gus Williams, tabled a proposal that:

"The Norfolk Branch will not except anyone other than retired police officers, their widow/widower as a 'Member'"

This proposal was unanimously agreed by the Committee.

To clarify what this means:

Widows/Widowers of eligible Full Members may become Members of the Branch (non paying).

Full Members of another Branch may become Members of the Norfolk Branch.

The situation and proposal was explained to the AGM by the Secretary and discussion/questions offered.

The above proposal was put to the vote of the AGM, and was passed almost unanimously.

TREASURERS REPORT 2017

Treasurer's Report Financial Year 1st January to 31st December 2017 I am pleased to present my fifth Treasurers Report and once again I can report the Branch Funds are very healthy. The Balance Sheet is prepared in accordance with the requirements of the National office and can be summarised as follows:

Total balance carried forward from 2016 : £40614.69

Total Income in 2017 : £18955.12

Total expenditure in 2017 : £14319.40

Balance at year end : £45603.90

There has been a steady growth in our income due to the continued increase in our membership numbers and the annual increase in subscriptions which is set in our Fund Rules and relates to the annual increase in the Police Pension. The Branch retains 60% of the total and has to send 40% (the precept) to Wakefield, the national office. Included in the income are the social event ticket sales and there was fewer such events in 2017.

On the expenditure side, there is an expected increase in the precept. As the subscription income increases so it follows the precept payable to the National Office (40%) will also increase.

Conference expense was slightly down on 2016. This is predominantly due to location and the deals that can be achieved on Hotel rooms.

The cost in producing and circulating the Branch Newsletter is down in 2017 but this reflects the fact that there was a reduction in the number produced. It is hoped this will be rectified in 2018 and so the cost will revert to a more realistic figure as represented in 2016. Every effort is being made to send the Newsletter by email to as many members as possible, however we are very much aware that we have some very senior members who are not on e-mail and will require their correspondence by royal mail.

The expenditure under IT and Consumables includes the purchase of a suitable Laptop with software for the Assistant Secretary and includes the cost of printer cartridges.

There is an increase in the cost of meetings, 4 Committee meetings and the AGM. This reflects the general annual increase the venue has levied. We have looked at the costs of other venues and we held the January Committee meeting this year at Ayton House, Wymondham that gave a small yet significant saving of £30. We will continue to monitor this cost. The figure under Social Subsidies has to be put into context. To get an accurate figure it is necessary to deduct the income of £1854.00 under ticket sales from the expenditure which reveals a true figure of £348.35 for 2017, substantially less than 2016 There was a conscious decision following the 2015 AGM to increase the number of events and to provide effective subsidies as a means in encouraging the membership to support these events, however, it has been difficult to find a member who is prepared to organise more events. In particular Great Yarmouth did not have a Christmas Dinner event this year.

There is an increase under the heading of Welfare Grants. The 2016 figure was significantly lower than 2015 and as reported last year this figure will fluctuate depending on the needs of the membership.

Miscellaneous expenditure is down as the 2016 accounts included a donation to the Police Arboretum Trust of £1050.

Expenditure under the remaining headings has remained very much the same.

Finally when you look at income over expenditure there was a surplus in 2017 of £4635.72 with monies at the bank at the 31st December 2017 totalling £45603.90

I commend this report to you.
